Editor-in-Chief

Cassandra Lawrenson is the Editor-in-Chief and has overall responsibility for the management, control, and direction of the Law Review—the flagship scholarly publication of TJSL—and is vested with authority commensurate with that responsibility. She is authorized to allocate to and among members of the Law Review’s Editorial Board such powers and duties as seem appropriate and necessary for the proper functioning of the Law Review. She must ensure the publication and distribution of at least two editions of the Journal during her tenure. The Editor-in-Chief is a member of both the Notes and Articles Committees. She is also the Law Review’s representative to administration, faculty, and students of TJSL.

Managing Editor

Christina Hebert is the Managing Editor and has the responsibility for the day-to-day work assignments and operation of the business and managerial aspects of the Law Review’s work. She is respon-

sible for business accounts, disbursements, and funds of the Law Review. She is the liaison with the Journal’s printer. The Managing Editor is also responsible for the solicitation of advertising, subscriber servicing, and the keeping of all books and records of the Law Review. She must publish at least two editions during her tenure and is responsible for distributing the Journal.

Executive Editor

Sean Leedom is the Executive Editor and is responsible for the day-to-day work assignments and operation of the editorial aspects of the Law Review’s work. His responsibilities include coordinating the selection of lead articles and book reviews, assisting and supervising the Chief Notes and Chief Articles Editors, supervising the editorial and technical aspects of preparing articles for publication, and other duties to assist the Editor-in-Chief as assigned. The Executive Editor is a member of both the Notes and Articles Committees. He must publish at least two editions of the Journal during his tenure.

The new board will attend the National Conference of Law Reviews where they will learn the latest law review trends and how to use them to improve our Journal.”



Professor Cohn Featured at International Lawyers' Conference in Brussels

From April 15-19, Professor Marjorie Cohn attended the 18th Congress of the International Association of Democratic Lawyers in Brussels. She was reelected to the Bureau of IADL and she continues to serve as Deputy Secretary General and chair of the IADL Scientific (Scholarly) Committee.

Progressive lawyers from more than 56 countries representing 50 national associations attended the meeting, which was held on the campus of the Vrije Universiteit Brussel. The four official languages of the conference were English, French, Spanish and Arabic.

Professor Cohn served as co-president of the all-day Commission on Impunity and International Justice, at which she also presented papers on "The Struggle for the International Criminal Court's Jurisdiction to Punish the Crime of Aggression," and "The 'Responsibility to Protect' vs. the United Nations Charter."

The other commissions included Peace and the Crisis of International Law; Democratic Peoples' Justice, Independence of the Judiciary and Protection of Lawyers; Labour and Trade Union Rights in the Neo-Liberal System; Rights of Migrants and the Struggle Against Racism; The Right to Resist, to Protest and to Organize; Crisis, Debt and the New Democratic International Economic Order; Lawyering for Defending and Promoting Peoples' Rights; The Human Right to a Clean and Healthy Environment; and The Struggle for Gender Equality and Against Discrimination.

Professor Cohn also moderated a discussion on achieving justice and compensation for the Vietnamese victims of Agent Orange, in cooperation with the Vietnamese Association of Victims of Agent Orange. It focused on the use of chemical weapons by the United States during the Vietnam War and its devastating consequences. A resolution and a plan of action emerged from the workshop. Professor Cohn is co-coordinator of the Vietnam Agent Orange Relief and Responsibility Campaign in the U.S.

Professor Cohn also convened a meeting of the Scientific Committee, which includes native English, French, Spanish and Arabic speakers. The Committee is collecting scholarly papers on topics presented at the Congress in order to publish a book. The Committee also assists in the publication of the IADL Review, prepares submissions to the UN Economic and Social Council in the New York, and will present webinars to educate lawyers about international human rights law and international humanitarian law.

In addition, Professor Cohn participated in the committee that drafted the Final Declaration of the Congress.

Highlights of the Congress included an address by Kumi Naidoo, International Executive Director of Greenpeace International, who spoke about "The Right to a Clean and Healthy Environment," President Emeritus of Center for Constitutional Rights Michael Ratner's talk on "The Age of Surveillance," and UN Independent Expert on the Promotion of a Democratic and Equitable International Order Alfred de Zayas, who spoke about his mandate.

According to Professor Cohn, "The IADL holds its Congress every five years. This is the fourth Congress I have attended, and I am more impressed than ever at the high level of discussion and work by these talented and committed lawyers whose organizations include thousands of progressive lawyers around the world. I am honored to be part of this organization."

ALTERNATIVES TO PARKADE PARKING

For students who need to come to class or stay on campus after the time you must exit the Padres Parkade garage, there are four options:

Option 1 – Street Parking There is limited free street parking east of Park Boulevard and also North of G Street. The key to getting the free spots is to get to them early on in the day. We also offer security escorts for students back to their car during the evenings. Meter parking

is generally free after 6 p.m. in the surrounding area as well, but you have to pay for parking any time before 6 p.m..

Option 2 - Park at Trolley Lot & Ride Trolley to Campus Students can drive to one of the (3) free Trolley Station parking lots listed below and then take the trolley to the Law School. The Park & Market station on the Blue and Orange line is located directly across the street from the law school. A trolley day pass is \$5.00. You can also purchase a monthly trolley pass from the Business Office located on the 6th Floor for \$57.60.

Qualcomm Stadium Station (Mission Valley) – 5,000 Free Spaces 9449 Friars Rd.

Hazard Center Station (Fashion Valley) – 1,500 Free Spaces 7611 Hazard Center Dr.

Old Town Transit Center (Old Town) – 787 Free Spaces 4009 Taylor St.

Option 3 – Carpools There are a limited number of carpool spaces available in the underground parking garage underneath the law school building. To be eligible to park free of charge under the building, the carpool must consist of 3 or more people. You must email Assistant Director of Admissions, Justin Cruz at jcruz@tjisl.edu with the names of the 3 students who will be in the carpool, the make, model, color and license plate number for each car in the carpool group. All 3 students must be present at all times upon entering the parking garage. Confirmation will be sent once you are approved. Please be advised that space is limited. The law school garage entrance is located at 445 11th Avenue.

Option 4 – Alternative Parking Garages near Downtown The Padres host a web-site that lists other Parking Garages in the area that are available during the game. Please visit the following web-site for specifics regarding location and cost to park at the garages.

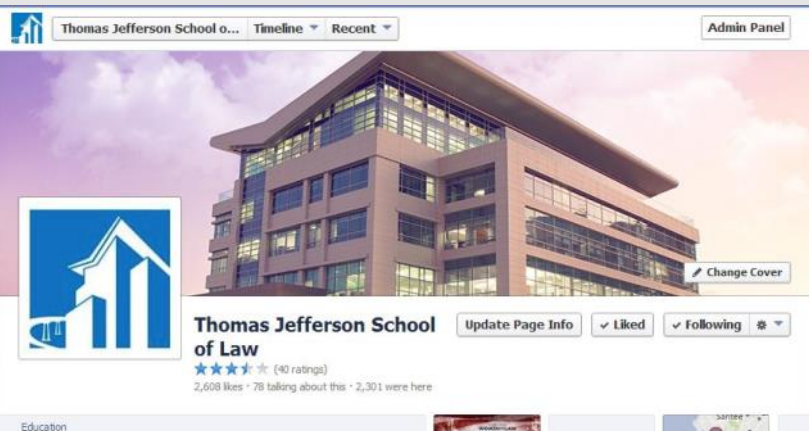
