The [U.S. Securities and Exchange Commission \(SEC\)](#) 2012 2L Summer Honors Program application has opened. Interns directly support attorneys and other professionals in the regulation and enforcement of the securities markets. Each intern is assigned to one of the SEC's offices or divisions for a ten-week period. The potential assignments are as varied as the SEC's responsibilities in regulating the securities markets. They have high expectations for their interns, often assigning them the same work they would give a newly-hired staff attorney who had completed law school. Students who succeed in their assignments assist with tasks such as drafting regulations, reviewing filings, or preparing for interviews and testimony. They spend hours every day with line attorneys, and they support senior executives.

## Alumni Opportunity: Two Attorney Advisor Positions

Department of the Navy – Office of the Chief of Naval Operations has two vacancies in San Diego for their Attorney Advisor position. The attorney advisor provides legal advice, legal briefings, and counsel to those service members in the Navy Disability Evaluation System (DES) process. Practice areas include: Administrative Law, Disability Law/Rights, Health Law/HIV-AIDS Issues and Litigation.
