3Ls: Environmental Law Fellowship/Staff Attorney Opportunity in D.C.

The Institute for Public Representation at Georgetown University Law Center is currently recruiting for a two-year fellowship position focused on environmental law. This fellow will focus on individuals and communities, primarily in the Washington metropolitan area, who suffer a disproportionate share of environmental harms and enjoy fewer environmental amenities than other parts of the area. Issues explored include the Clean Air Act, the Clean Water Act, the Endangered Species Act, the National Environmental Policy Act, and federal hazardous and solid waste laws. In addition to an annual stipend of \$35,500, the Law Center will award an LLM to the fellow upon completion of the two-year term.
