3Ls: Post-Bar Legal Research Assistant Opportunities with the Sacramento County District Attorney's Office

The Sacramento County District Attorney's Office is accepting applications for post-bar Legal Research Assistants to begin work after taking the February 2013 or July 2013 California Bar Exam. Legal Research Assistants will work under the supervision of deputy district attorneys doing legal research, assisting in court, and handling assignments in the misdemeanor arraignment court.
